To attain certification as a driving instructor in British Columbia, adherence to the standards established by ICBC is imperative. Throughout this course, your commitment and engagement are pivotal for a successful journey toward qualifying as an ICBC licensed practical driving instructor. The criteria for course completion include:

Course Attendance: Attend every session of this course.

**Entrance Exam:** Successfully pass the entrance exam, demonstrating your understanding of basic driving rules and regulations.

**Pre-course Driver Assessment:** Meet the standards set in our pre-course driver assessment, showcasing your practical driving skills.

**Observation Hours:** Observe 6 hours of Driving Lessons with one of our partner schools and submit a completed Hours Tracking Form.

**E-Learning:** Complete Defensive Driving Fundamentals and Attitudes eLearning program to expand your perspective on driver psychology and enhance your knowledge on defensive driving.

**Knowledge Assessments:** Achieve a minimum score of 80% in the knowledge assessments, validating your grasp of course material.

**Practical Sessions:** Deliver two practical sessions, each lasting at least one hour. These sessions will be observed by an Assessment Officer, and a minimum score of 64% is required to pass.

**Competency Checklist:** Demonstrate competence in all the required knowledge and skills outlined in the ICBC Competency Checklist.

Your commitment to fulfilling these requirements is essential for a successful certification process. Trust that our guidance and support will facilitate your achievement of the necessary standards. # Policy

#### **Attendance**

Course hours are scheduled from 8:00 am to 4:00 pm, Monday to Friday. Full attendance throughout the program is mandatory for participants to successfully pass the course. Tardiness or partial absence on any day may result in a mark of incomplete. Participants are responsible for promptly communicating with instructors to arrange makeup sessions for any incomplete sessions.

#### **Behavior**

In the Instructor Training Course, adherence to the following guidelines is strictly enforced:

- Prohibition of Substance Use: Participants are prohibited from the possession, use, or being under the influence of alcohol, cannabis, or illicit drugs during course hours.
- Weapons Policy: Carrying weapons is strictly forbidden.

## How to Enroll

### Step 1: Request an Instructor Application

Begin by requesting an instructor application to ensure you meet the necessary qualifications. You can request this by calling ICBC toll-free at 1.866.339.0363 or online at <a href="https://onlinebusiness.icbc.com/eforms/dotcom/jsp/dtas\_instructor\_application\_request.jsp">https://onlinebusiness.icbc.com/eforms/dotcom/jsp/dtas\_instructor\_application\_request.jsp</a>

## Step 2: Application Package

If you qualify, ICBC will send you an application package, which includes:

- An application form
- A medical evaluation form (to be completed by your physician)
- A criminal record search request letter

Complete all parts of the application and send it to the address provided in the package. Do not include your \$30 license fee at this stage. The fee is only required after completing the training course.

#### **Step 3:** Register for the Instructor Training Course and Deposit.

Fill out the registration document found on the next page and email the completed form. To hold your seat, a deposit of \$1000 is required. This deposit is refundable up to 45 days before the first day of the course.

#### Step 4: Entrance Knowledge and Skills Test

You must pass a knowledge test (multiple choice) and a skills test (in-car driving – similar to a road test) to gain admission into the ITC. To prepare, we recommend:

- Reading "Learn to Drive Smart" and "Tuning Up for Drivers"
- Motor Vehicle Act Section 119-231
- Motor Vehicle Act Regulations Divisions 4, 18, 42, and 47
   (Links to these materials are provided at the end of this information package)



**Step 5:** Class 7 Observation

Complete 6 hours of live observation of a Class 7 driving lesson. You will observe a licensed instructor delivering a lesson to a student from the back seat. Scheduling for observation will occur after you pass the entrance tests.

Step 6: Attend Thinking Driver ITC

Step 7: Submit Completion Certificate and Fee to ICBC

After completing the instructor training course, mail the following to ICBC:

- Your course completion certificate
- \$30 license fee (cheque payable to ICBC)

If you plan to teach at multiple branch offices or schools, you will need to display a license at each location and request additional licenses at \$15 each.

Please note that any outstanding debts to ICBC must be settled before an instructor's license is issued.

Once ICBC receives your course completion certificate and fees, they will send you your instructor license, allowing you to begin instructing at a licensed driving school.

# Glossary

**Assessment Officer** (AO) – An Assessment Officer is an individual responsible for evaluating the performance of instructor candidates during various stages of the Instructor Training Course. AOs assess candidates' instructional skills, knowledge of traffic laws, and their ability to effectively communicate driving principles. Their evaluations play a crucial role in determining whether a candidate is qualified to become a certified driving instructor.

**Defensive Driving** – Driving to prevent incidents regardless of the driving conditions and actions of others.

**Graduated Licensing Program** (GLP) – The program that ICBC introduced to help new drivers gain experience gradually, under conditions that expose them to less risk.

**ICBC-approved course** – A driver education course that meets specified requirements that ICBC has set. New drivers who complete an ICBC-approved course are eligible to receive a six-month reduction in the novice stage if the driver remains violation- and atfault crash-free for the first 18 months of their novice stage (Class 7 only).

**Instructor Candidate** (IC) – An individual participating in an Instructor Training Course and looking to become certified as an instructor.

Insurance Corporation of British Columbia (ICBC) – A provincial government corporation responsible for providing automobile insurance, driver licensing services, and vehicle registration in British Columbia. As a key player in road safety, ICBC also sets and enforces driving standards, conducts road tests, and implements programs such as the Graduated Licensing Program (GLP) to enhance road safety.

**Instructor Trainer** (IT) – An experienced driving instructor delivering an Instructor Training course to help candidates become instructors.

**Instructor Training Course** (ITC) – A comprehensive program designed to equip individuals with the necessary knowledge and skills to become certified driving instructors in British Columbia. This course covers instructional techniques, traffic laws, and effective communication strategies to prepare candidates for a successful career in driver education.

**Justice Institute of British Columbia** (JIBC) – An educational institution that collaborates with ICBC to deliver the Instructor Training Course (ITC). The JIBC plays a crucial role in training and certifying driving instructors, ensuring that they meet the standards set by ICBC and contribute to the development of safe and responsible drivers.



**Learn to Drive Smart** (LDS) – Whether you are new to British Columbia, taking a re-examination, or brushing up on your driving skills, the Learn to Drive Smart guide gives you the basic information to help you drive safely. The guide will also help you prepare for the knowledge test, and Class 7 and Class 5 road tests.

**Learner-centered** – Instruction that's based on the needs of the students. To make their course learner-centered, instructors generally try to adapt their instruction to different learning rates and styles, recognize cultural differences, and value the experiences and ideas of their students.

**Lesson** – One or more learning activities selected to achieve specified learning outcomes. A lesson will usually include several different activities.

**Lesson Plan** – A plan designed to teach a particular topic or topic, including an introduction, detailed activities, and a summary.

**Mapping a Safe Course** – The curriculum document that outlines the course content, assessment strategies and instructional strategies to be used in an ICBC-approved course.

**Motor Vehicle Act** (MVA) – The provincial statute governing the operation of motor vehicles on British Columbia highways.

**Motor Vehicle Act Regulations** (MVAR) – These extensive regulations, enabled by the Motor Vehicle Act, cover topics such as vehicle inspection and maintenance requirements, driver licensing, cargo securement, and commercial vehicle safety code requirements.

**Motor Vehicle Branch** (MVB) – The Motor Vehicle Branch is a division within ICBC that handles various aspects of vehicle registration, licensing, and compliance with motor vehicle laws. It is an essential entity for both drivers and driving instructors, as it oversees the administration and enforcement of regulations related to road safety and driver education.

**Tuning Up for Drivers** (TUFD) – The guide is issued to the new driver when he or she gets a learner's license. It's designed to help the supervisor work effectively with the new driver to promote safe driving skills and attitudes.

**Running Commentary** – A driver's ongoing description of what they are seeing, doing, and planning to do. This can be done by an instructor or a student.

**Supervisor** – An experienced, fully licensed adult non-professional driver who helps a new driver become a safe, skilled driver.
